From the FWC President:

Greetings and welcome to the start of a new academic year from the Faculty Welfare Committee Executive Committee! This newsletter will provide you with a summary of our recent activities, many funded by your FWC dues. For those of you who are new to campus, the Faculty Welfare Committee/AAUP is an ad hoc committee of the General Faculty and a chapter of the National AAUP. Our goal is to promote the professional and economic interests of the Fairfield faculty. These interests include academic freedom, tenure, the economic status of the faculty, and governance issues on campus. Any member of the Fairfield faculty may join the FWC. (Please contact the Membership Director, Prof. Betsy Bowen at bbowen@fairfield.edu for information.) Our activities are designed to benefit all faculty members, but are funded entirely by the dues paying members. At last count, over 71% of our faculty are FWC members.

As the governance issues and matters related to fiscal policies in the *Faculty Handbook* come before the Academic Council and the General Faculty, I would like to remind you that the FWC has decided not to take a position on the proposals but to do what we can to help educate the faculty on the matters to be decided. Watch for future newsletters with this educational goal in mind. Although the leadership of the FWC is uncharacteristically divided on the best course of action for the faculty, I feel confident that each member of the FWC Steering Committee has the best interests of the faculty at heart. I am convinced that we will be able to work through the situation collegially, despite our differences, and come out a stronger organization in the end.

I hope you enjoy this edition of the newsletter and I encourage you to become involved in the FWC. As a faculty organization, we are only as strong as our membership makes us.

UPCOMING FWC, AAUP AND OTHER FACULTY EVENTS:

ACADEMIC COUNCIL MEETING Monday, 9/14, 3:30-5:00 CNS 200

The Academic Council is the executive arm of the General Faculty, empowered to consider, make decisions and make recommendations on matters that fall within the purview of the faculty. The AC consists of 17 faculty members elected by their colleagues and 7 ex officio non-voting members (the SVPAA, the Deans of the 6 schools, and the General Faculty Secretary (GFS)). At the first meeting on 9/14, they will hear a report from the AC Subcommittee on Governance from the Faculty Salary Committee on upcoming proposals, both reports include proposed amendments to the Faculty Handbook. The FWC/ AAUP encourages faculty to educate themselves about these proposals. Materials can be found on the GFS website at www.faculty.fairfield.edu/gfs. Consult any member of the AC Subcommittee or the Salary Committee for more information. It's essential that every faculty member understand the proposals

coming to the faculty for consideration. Any faculty member should feel free to contact any member of the AC to discuss and/or provide input.

The Summer Institute is the AAUP's premier resource for training in faculty leadership and advocacy. Last July, the SI was held on the campus of Macalester College in St. Paul, MN. Four faculty leaders were able to attend due to very generous funding from National AAUP and the CT State Conference. Cheryl Tromley, a first-timer, attended a four-part workshop on Contract Negotiations, designed to provide training in the complexities of bargaining and negotiations. Susan Rakowitz, Rick DeWitt and Irene Mulvey (all returnees) attended a variety of workshops, including, Faculty Advocacy: Understanding and Strengthening Faculty Handbooks, Developing Shared Governance, Organizing 101: Building a Strong Chapter, and Higher Education Data and Research. Highlights included connecting with colleagues from previous summers and meeting up with a new team from Assumption College in Worcester, MA. Kathy Nantz and Irene Mulvey were invited to their institution last March when they were just thinking about forming a chapter and now they're sending members to the SI! Fairfield's FWC/AAUP Newsletter receives the Assembly of State Conferences Award for Outstanding Chapter Newsletter

At the AAUP's annual meeting in June, we were thrilled to accept, on behalf of the chapter, the award for Outstanding Chapter Newsletter from the Assembly of State Conferences newsletter award committee. The award is for our newsletters for calendar year 2008 (ours are all online under Miscellaneous Publications on the FWC website, see footer), so the judges hadn't even seen our terrific six and eight page newsletters from last spring. All the entries were praised for thoughtful and useful content, a sense of responsibility to a constituency and the linkage to National AAUP's principles and organizational needs. The particular citation, read by Ruth Anne Baumgartner, for the FWC as winner of this year's outstanding chapter newsletter, is as follows:

"Last year the Fairfield newsletter won an Honorable Mention in this category; in the course of a year it has only gotten better. This year Fairfield's newsletter was the unanimous winner, although I should mention that since I teach parttime at Fairfield I cast my vote in this category only to make the decisive majority unanimous. This excellent publication is

newsy and chock-full of the kind of information a faculty organization would want to have. The committee especially mentioned some of the ongoing features, such as "From the Archives"—which, we should note, might sometimes benefit from more context. The writing is clear; the layout is clean and creative; the overall feel is of energetic community."

The award comes with a plaque and a check for the chapter for \$100. Irene Mulvey, who attended the Annual meeting as a member of the National Council and president-elect of the CT State Conference was on hand to accept the award. Many thanks to all of our members who contributed to the newsletter last year. We hope to solicit more opinion pieces in the year ahead. Connecticut State Conference/AAUP Annual Spring Meeting

The theme of the CSC/AAUP Annual Spring Meeting last May was "Managerial Discretion and Professional Autonomy in a Time of Fiscal Crisis". There were a record number of close to 80 attendees, including at least thirteen members from Fairfield's FWC. Speakers were Judith Greiman, President of the Connecticut Conference of Independent Colleges, Elsa M. Nuñez, President of Eastern Connecticut State University, and Gary Rhoades, General Secretary of the AAUP. The discussion was extremely thought-provoking. In fact, it was remarks at this event by panelist Dr. Nuñez that

prompted the FWC Steering Committee to write to President von Arx, S.J., last summer responding to the layoffs with a call for transparency in criteria and process, and more open participation by the community in decision-making. (See 7/15/09 FWC newsletter on the FWC website.)

Presentation of the CSC/AAUP George E. Lang, Jr. Award

A highlight of the CSC Annual Spring meeting was the presentation of the Lang award. Our colleague, George Lang, passed away suddenly in May 2007 after a brief illness. As most everyone knows, he was extremely active in the FWC, the CSC and National AAUP. The CSC established an award to honor the memory of George by recognizing a faculty member at Fairfield who early in his or her career has shown awareness of



and dedication to important AAUP principles such as academic freedom, faculty governance and faculty rights and responsibilities. The award comes with a plaque, an AAUP lapel pin, a *Redbook*, and the CSC picks up the recipient's AAUP dues for a year. Fairfield's FWC has the honor of selecting the recipient and the FWC Executive Committee chose Bob Epstein. In addition to his ongoing service to FWC as a member of the Executive Committee and past newsletter editor, he was cited for consistently presenting clearheaded arguments on any number of matters that affect faculty as well as being fearless in speaking truth to power. We think George would be pleased.

Fairfield University values each of its students as an individual with unique abilities and potentials, and it respects the personal and academic freedom of its members.
