FWC/AAUP Open Meeting on April 1:

Thank you to all members of the Faculty Welfare Committee/AAUP who were able to attend the FWC meeting on April 1. We elected our delegate to the annual meeting of the Collective Bargaining Congress (CBC) in a secret ballot election, which is necessary since the CBC is required to follow regulations in the Labor-Management Reporting and Disclosure Act. The CBC is more important than ever, now that collective bargaining rights are under attack nationwide. We will provide a report of the CBC meeting in a newsletter next fall.



Amendments to the FWC Constitution:

Thank you to our members who voted in the electronic election to amend the FWC/AAUP Constitution. The Executive Committee worked for several meetings on the language and consulted with the legal department at National AAUP on the revisions which are entirely for the purpose of assuring that our chapter meets the IRS requirements as a 501(c) (3) tax exempt organization.



Annual FWC Faculty Attitude Survey:



Your FWC/AAUP dues and National AAUP

The FWC/AAUP is a committee of the General Faculty and a chapter of the national American Association of University Professors. Any member of the General Faculty at Fairfield may join our chapter by contacting any member of the Executive Committee. Dues are collected by payroll deduction. The major portion of each member's dues payment goes to National AAUP. Although it's impossible to convey the volume, the breadth and the importance of the work done by the national office, here are some of the highlights that your dues payments support.

Salary Survey

At this time of year, there is a lot of talk about "the 95th percentile" since our administration and Board of Trustees are committed to keeping the average compensation in each rank at or about the 95th percentile. This benchmark refers to the AAUP's annual survey of faculty compensation, data collected from universities all over the country and collated by the national AAUP. This data represents the standard of our profession and without an incredible amount of work each year by senior staff in the national office would not exist.

ACADEME

The salary survey, by which we benchmark our salaries, is published every year in the March-April issue of ACADEME. Every member of the AAUP receives ACADEME, the magazine of the AAUP which contains higher education

new articles, opinion pieces, book reviews and feature articles. In addition to ACADEME, the AAUP publishes statements on current issues on their website, and publishes AAUP Policy Documents and Reports (The Redbook), the authoritative source for the principles underlying sound academic practice. The 1940 statement is referenced in our Faculty Handbook and on most campuses with genuine shared governance. It's hard to imagine American higher education without the fundamental AAUP principles so articulately presented in the Redbook.

Government Relations

Within the office of Research and Public Policy (the office responsible for the salary survey), the Government Relations (GR) program tracks legislation, works to build relationships with policymakers, and is, in general, a valuable resource to members who want to become more active in influencing policy making and decisions at the local, state or national level. Capitol Hill Day, which CT faculty members have participated in for many years, is an event held every June. Members of the GR staff provide lobbying seminars and talking points so that faculty, organized by state, descend on Capitol Hill to lobby their senators and representatives on current issues affecting higher

education.

The Legal Department in the National office, working with experts from around the country,

submits amicus briefs in key cases in order to shape the law in ways that support AAUP principles. Lately, many of these amicus briefs have been successful (all are on the AAUP website). The Garcetti campaign, in particular, is an ongoing effort to assist faculty in defining academic freedom as a professional standard that encompasses all aspects of faculty work and should be integrated as such in institutional governance documents.

Skeletal Staff

This is only a fraction of the work done at national. We haven't discussed the work leading to censure or sanction of an institution or the tireless work of the Department of Organizing and Services. Believe it or not, all the work in the national AAUP office is done by a few dozen individuals. Furthermore, all the work of the national office is funded by the dues of AAUP members like you.

Your FWC/AAUP dues and the State Conference

A state conference is an umbrella organization serving all the chapters in that state. About 30 states have state conferences and Connecticut has an extremely active state conference. A tiny portion of your FWC/AAUP dues (\$7/member/year) goes to fund the activities of the CT State Conference-AAUP.

The CSC-AAUP Executive Committee meets every month to conduct conference business. The conference holds an annual spring meeting for all the members in the state on a topic of interest to the members and with speakers addressing that topic. (See information in box below). The CSC-AAUP publishes *Vanguard*, an award-winning conference newsletter. On April 13, conference members participated in a day of

action in defense of higher education by lobbying state legislators at the state Capitol on the education provisions in the governor's budget and the proposed legislation to reorganize Connecticut's public colleges.

Many individuals who find themselves involved in a conflict involving academic freedom, tenure or shared governance are not members of the AAUP and/ or work at institutions which do not have an AAUP chapter. Without a chapter to turn to for advice, these individuals turn to the state conference or to national AAUP. Typically, the state conference is the first step in attempting to resolve a dispute. Two years ago, an adjunct faculty member at the University of New Haven, who was wrongly terminated without due process,

contacted the state conference.

This case resulted in UNH being put on the AAUP's censure list in June 2008, then revising relevant policies to be in line with AAUP principles in 2008-09 in order to be removed from the censure list in 2009. The CSC-AAUP was totally involved in this case from start to finish, providing advice and support to the affected faculty member and to the investigating team that undertook the investigation which led to censure.

The conference budget is small and most of the work is done by the faculty members elected to the CSC-AAUP Executive Committee. But the important work of the conference is funded by dues payments from AAUP members in the state of Connecticut like you. Thank you.

Your FWC/AAUP dues and the Chapter

Fairfield's Faculty Welfare Committee/AAUP is an AAUP advocacy chapter that is affiliated with the national AAUP. As you've read, affiliate chapters provide the finances for the AAUP to conduct all its business, and build a strong membership base for the organization. Being an AAUP member indicates that a faculty member is concerned about academic freedom and about the way that basic freedom protects teaching and research. Having an AAUP chapter indicates that there is a cohesive group of like-minded faculty members who want to participate in meaningful faculty governance and genuine shared decisionmaking. Having a chapter as active and as well-respected as Fairfield's FWC/AAUP, with membership at over 70% of the faculty, means that the vast majority of Fairfield faculty believe it is their professional responsibility "to advance academic freedom and shared governance, to define fundamental professional values and standards for higher education, and to ensure higher education's contribution to the common good."

All of the FWC/AAUP activities are open to all members of the General Faculty, but are funded entirely by our dues-paying members. Some of our activities are designed to bring us together as colleagues - the gala receptions after faculty meetings and breakfast before the election meeting are rare opportunities to connect with fellow faculty members across departments and schools. Our picnics and softball games are the only events for all Fairfield faculty and their friends and families. And, we run these events on a shoestring budget. Your dues fund our awardwinning newsletter and the snacks at our Brown Bag Lunch discussions. We are always looking for input from our members so if you have an idea for a Brown Bag, or a newsletter or a new event, contact any member of the Executive Committee, listed on the back page.

Our FWC/AAUP treasury is crucial when we need legal advice. Several times in the past eight years or so, the Faculty Salary Committee consulted an attorney over various contract issues. Simply put, this would not have been possible without the FWC. Our attorney's advice on contract language and strategy has been invaluable to all of Fairfield's faculty but is entirely funded by the dues-paying members of the FWC. Our chapter now has a "legal fund" of several thousand dollars set aside for legal expenses, when needed.

The Executive Committee meets every month to conduct business on your behalf. At the last meeting, it was decided that the time was right to remind the membership of the important work done by the AAUP at the local, state and national levels and to thank the members because it is member support and member dues that make our chapter strong.

The FWC Executive Committee thanks you for your ongoing support of the Faculty Welfare Committee and the AAUP.




Faculty Welfare Committee/AAUP Newsletter Fairfield University
