

# **FWC/AAUP** Action at Commencement

#### From the Co-Chairs of the FWC/AAUP Action Committee:

We would like to inform the faculty of the action we engaged in at Commencement. A flyer was drafted and distributed to guests at Commencement as they arrived. The text of the small flyer is below. The intent of the Action Committee in carrying out this action was to put pressure on the administration to reach agreement with the FSC at its 5/18 meeting. Although no final agreement was reached on 5/18, some progress was made and another meeting between the FSC and the administration was scheduled for 5/24. This meeting is reported on elsewhere in this issue, and the Action Committee continues to monitor the situation and plan accordingly.

Many members of the Action Committee participated in deciding on and planning the event, and we thank all members for their input and suggestions. Thanks to the members who drafted the flyer and had it printed on Fairfield red paper. Thanks especially to the eight members who volunteered to distribute the flyers in advance of the undergraduate ceremony wearing their academic regalia.

The FWC Action Committee did not expect the heavy-handed tactics from public safety officers and Fairfield police officers. Our volunteer faculty members were told to stop distributing flyers and leave. Our volunteers remained polite and respectful, asking who ordered them to stop distributing flyers and what law or regulation that applied to a member of the General Faculty was being violated. Those questions enabled the volunteers to continue distributing the flyers until everyone in attendance was asked to clear the aisles as the ceremony began. The Faculty Secretary has asked upper administration for an explanation of what occurred concerning public safety officers and Fairfield police officers, and will follow up with the Academic Council as needed. In all, our member-volunteers distributed all 3500 flyers.

#### Our Creative Proposal for Health Care Cost-Share Amounts:

We have often been told that when budgets are tight, we all have to sacrifice and when times are good, we will all share in the surplus. Currently, the administration is proposing that faculty pay 12% of health care premiums in 2013, up from 10% in 2012 - an *increase* in the neighborhood of 25%. Given that enrollment numbers for the fall look good, the FSC proposed the following, which has the effect of making real the promise of shared sacrifice when needed, and sharing in the surplus when possible.

- If on 10/1 (according to mutually-approved official sources), revenue from tuition and room & board exceeds budgeted revenue by 400K or more, faculty pay 10% of health care premiums.
- If on 10/1, revenue from tuition and room & board exceeds budgeted revenue by 200K to 400K, faculty pay 11% of health care premiums.
- If on 10/1, revenue from tuition and room & board does not exceed budgeted revenue by 200K or more, faculty pay 12% of health care premium.

An even better take on the same theme, is the following:

- If (according to mutually-approved official sources), revenue from tuition and room & board is within 200K of budgeted revenue, faculty pay 10% of health care premiums.
- If revenue from tuition and room & board is below budgeted revenue by between 200K and 400K, faculty pay 11% of health care premiums.
- If revenue from tuition and room & board is below budgeted revenue by 400K or more, faculty pay 12% of health care premiums.
