As we prepare for Commencement, your elected colleagues on the Faculty Salary Committee want to update you on where we are with regard to our collegial discussions and agreement on terms of compensation and a Memo of Understanding.

Our last meeting with the administration was on May 10. The administration did not want to meet on May 17 and, as a result, the General Faculty meeting tentatively scheduled for May 19 was cancelled by the General Faculty Secretary.

The FSC Chair was invited to organize a group of five faculty members to meet for one hour with the Executive Committee of the Board of Trustees. I went, along with Sonya Huber (FSC and Health Care Committee), Bob Epstein (FSC), Walt Hlawitschka (HCC) and Susan Rakowitz (GFS).

The meeting took place on Wednesday, May 18. We found the meeting productive and we had a good conversation with the members of the Executive Committee. Time was limited, so we were not able to discuss everything that we wanted to discuss. Nonetheless, we expressed our concerns about the process this year-specifically, how long it took for the administration to make and respond to proposals, and how little the administration provided in the way of rationales for their proposals and for their rejection of our proposals. We also emphasized the context of the Faculty's response to proposals for health care changes this year, namely the fact that we have made a number of health care concessions since 2010, that the University's spending on health care has gone down, and that their current proposed changes don't seem to be justified. With regard to the last point, we explained the Faculty's objection on ethical grounds to the proposal of increasing the cost-share portion for spouses and children of employees by 50% - a change that would likely hit hardest those employees making less money and without spouses employed elsewhere. Finally, we indicated to the Board that we believe a multi-year agreement is possible as long as the administration fully and flexibly engages with us regarding the goals, forms, and schedule of health care changes.

The FSC and the HCC are on record with the administration and the Board Executive Committee that we are available and very willing to meet next week, that we are committed to working with the administrative team in collegial discussions to reach agreement on a Memo of Understanding to succeed the current MOU, that this is our joint objective.

We appreciate the many messages of support and encouragement and thanks that we get from so many of our colleagues, and we thank you in advance for your continued support.
