RE: Email from VP Pellegrino with Subject Line Summary - Administration's Economic Proposal FY17

We are writing to inform members of the General Faculty covered by the Memo of Understanding that the Faculty Salary Committee was blind-sided by the email from VP Pellegrino sent to members of the University community in the afternoon on April 19. On first reading, we find VP Pellegrino's message misleading in some places, and we are concerned that it contains some inaccuracies. For example, VP Pellegrino writes that the administration's proposal is a product of input from the Health Care Committee. However, the Health Care Committee was not given the opportunity to discuss and, in fact, did not discuss the changes to health insurance proposed by the administration and described in VP Pellegrino's memo. In addition we strongly object to the circumvention of the process of collegial discussions that this memo represents.

The FSC met with administrative team in the morning of April 19 and we are scheduled to meet again next week. The proposal linked to in VP Pellegrino's email is essentially the same proposal that we described and discussed in the General Faculty Meeting on Friday. The FSC is weighing possible responses to the administration's proposal in light of the serious potential short- and long-term impacts to our benefits, and we appreciate the patience and support of the faculty through this process.
